General Duties: Under supervision; is assigned to serve meals & snacks, assist with preparation of cold food items, wash and sanitize food service equipment, dishes & utensils, pots and pans, clean and sanitize dining room tables, serving and preparation areas.

Desirable Qualifications: Experience in preparation and/or serving foods and beverages, ability to follow direction and keep simple records, work independently and as a team member. Practice punctuality, good attendance and follow good personal hygiene practices.

Required Qualifications: Six months of experience in an institution, hotel, or restaurant, either serving, cleaning food service areas, or assisting with the preparation and service of foods and beverages.

Conditions of Employment: Pre-employment background check, fingerprints, tuberculosis test will be required.
