Position: Teaching Assistant (4 positions)
Area: Instructional Division
Tenure: Limited Term
Time Base: Intermittent
Salary: \$13.94- \$17.45 per hour

General Duties: Under the supervision of the Principal, the Teaching Assistant will provide services in the classroom and community to support the classroom teacher in the education of deaf students.

- Under guidance and supervision of the certified classroom teacher, work with students for small group lessons, individual instruction and large group instruction. Instruction may occur on campus or in the community.
- Assist in the preparation of graphic and written teaching materials and keeps routine records.
- Assist in supervision and escort of students around the campus, including to and from the dormitory, assemblies, cafeteria, infirmary, physical education and bus duty as well as off campus with fieldtrips or job sites.
- Operates classroom equipment; tutors students and grades objective examinations indicated by teacher.

Desirable Qualifications: Follow oral and written direction; possess knowledge of child guidance principles; evaluate situations accurately and take effective action, assist with supervision and learning activities. Read and write English at a level required for successful job performance. Experience working with children in a school or similar situation.

Required Qualifications: Proficiency in the use of American Sign Language (ASL).

Conditions of Employment: Pre-employment background check, fingerprints, and tuberculosis test.

These positions are designated as safety sensitive and are subject to reasonable suspicion drug and alcohol testing.
