General Duties

- Evaluate assigned personnel to ensure performance standards are met and support quality instruction. Facilitate the planning, communication, and evaluation of learning programs to promote excellence, equity, and access for all. Assist with scheduling, goal implementation, instructional material selection, test data analysis, instructional improvement, and teacher IEP assignments, including follow-up.
- Support Principals in supervising school activities, including field trips, orientations, assemblies, performances, athletics, and special events. Oversee co-curricular programs such as student activities, clubs, and athletics, and assist with planning school-wide productions and social events.
- Foster effective communication among staff, students, and families to resolve conflicts and support a positive school culture. Enforce policies and discipline procedures; address student behavior issues with proactive, preventative strategies. Oversee administrative functions such as attendance, scheduling, and student discipline. Support new staff orientation, lead sexual harassment panels, and manage complaints including bullying and harassment, ensuring accurate documentation.
- Assist the Principal and serve as acting Principal in their absence. Perform other duties as assigned to ensure smooth operation of the High School department.

Basic Requirements

- Minimum of five years' experience as a classroom teacher in a program for the Deaf
- Fluency in expressive and receptive American Sign Language (ASL) of at least a Level 4 ASLPI is required (evaluated through interview process)
- Fluency communication in Standard Written English
- Possess or be eligible to apply for a California Education Specialist Instruction Credential with an authorization in Deaf and Hard-of-Hearing.
- Possession of a master's degree or higher in Deaf Education from a regionally accredited college or university or be eligible for a master's degree at the completion of the California Administrative Services Credential program. Credentials must be approved by

the California Commission on Teacher Credentialing. Qualified applicants who do not meet the Administrative Services credential requirements at the time of hire, may be given up to three years to obtain their credential(s) see (<u>https://www.ctc.ca.gov/</u>) for more information on credentials).
